


Data in VHCURES All-Payer Claims Database

The Full Population between 2013 and 2018...

- The number in VHCURES increased by 7.2%
- The average age increased by 1 year
 - Ages 1 to 54 declined by 5.4% to 61% of the population (only the age group 25-34 years had an increase)
 - Ages 55 and older increased by 9.8% to **39%** of the population
- The percent with Medicare and Medicaid increased while the percent with Commercial insurance decreased, even after adjusting for the Gobeille decision
- The population saw a shift to higher risk health categories
 - The percent categorized as Healthy or Acute/Moderate Chronic declined by 5.5% to make up 58% of the full population
 - The percent categorized as Moderate, Significant and Catastrophic/Cancer increased by 8.7% to 42% of the full population.

Expenditures and Utilization






- Primary care Visits have increased

- 30-day readmissions increased






