

Logic Model (High Level)

Expand Community Health Team Capacity to Support Patient's Mental Health and Substance Use Disorder Needs

Inputs

- Community Health Team Funding
- Education and Training Funding
- Quality Improvement Facilitators
- Data and Measurement Funding

Activities/Outputs

- Screening
- Intervention
- Care management and coordination
- Training Sessions
- Implementation and integration activities
- Continuous quality improvement activities

Outcomes

- Increased Screening Rates
- Increased Access to Intervention
- Improved Coordination of Care
- Greater patient and provider satisfaction
- Neutral or decreased cost of overall care




