




Evaluation Questions - How do we know it's right?

We'll know we have near-perfect evaluation questions when:

- •Together, their answers will tell a high-level story of the initiative being evaluated
- •We have between three and ten questions
- •The questions cannot be answered by a simple yes/no, or by a number
- Indicators and methods are already suggesting themselves
- •Our stakeholders (and you!) breathe a sigh of relief when they read them



Spreadsheet

Question – from the Evaluation Framework

Indicator - different categories of information that help to answer the evaluation question

Measure - performance metric

Source – where the data comes from

Measure Type - structural (system capacity), process (how services are provided), or outcome (result)

Standardized Measure - measures which are validated by a measure steward and have specific parameters for reporting

Collection Type – how data will be transmitted to evaluator

Data Comments – any special considerations we discuss



Reviewing/Selecting Measures

Principle	Questions
Utility	 Does it address the evaluation needs of our stakeholder groups? Would you consider it a priority measure?
Feasibility	 Does it change based on program's stage of development (year 1 vs year 2)? How measurable are the items listed within existing infrastructure? What implications does it have on those asked to measure it?
Timeliness	 Will we be able to obtain the results within the required timeframes
Accuracy	 Is it an accurate representation of what is occurring?
